No provision of this assignment shall bar Assignee from collecting from Assignor any amounts paid by Assignee in satisfaction of the rental, royalty, related contract payments or tax obligations for periods prior to the date of approval of this assignment. Assignee certifies it is in compliance with all applicable regulations and authorizing acts.
